



## 2025-2026 Private Lesson Assistance Scholarship Program

The Private Lesson Assistance Scholarship Program was established in 2018 to support low-income families in paying for private lessons. The goals of the program are to provide opportunities for students who would otherwise be unable to afford lessons, to allow students to choose their instructor, to increase the diversity of the membership of the Spokane Youth Symphony, and to raise the overall caliber of all orchestras in the organization.

### Eligibility & Application

Students who participate currently in any of the Spokane Youth Symphony orchestras and who qualify for free or reduced-price meals during the school year may be eligible for assistance through the program (*depending on availability of funds*). Students who wish to participate in the program must submit an application that includes a letter showing qualification for free/reduced meals. If this is not available, they may submit a statement of family income, household size, and proof of income. The application will also state the student's instrument and the name and mailing address of their instructor. A committee of the SYS Board of Directors will review and approve the applications.

IMPORTANT: The SYS family is responsible for locating a private teacher who will agree to the terms of the program. A private instructor list with phone numbers can be found at [www.SpokaneYouthSymphony.org](http://www.SpokaneYouthSymphony.org) under Member Info.

Note: Teachers who are listed on our website are not required to participate in this program. Instructor participation in the Private Lesson Assistance Scholarship program is completely voluntary.

### Lesson Schedule & Fees

The program will help pay for 2025-2026 members of our four orchestras who financially qualify for the scholarship for up to four lessons per month during the SYS season (Sept - May) with a maximum of 30 subsidized lessons per year, per student. The length of the lessons will be agreed upon by the instructor and the student's family, with the family paying the difference to the instructor between the scholarship amount from SYS and the instructor's agreed-upon fee.

### **Private Lesson Scholarship Program**

#### Eligibility & Application

Students who participate in any of the Spokane Youth Symphony orchestras and who qualify for free or reduced-price meals during the school year are eligible for assistance through the program. Students who wish to participate in the program must submit an application that includes a letter showing qualification for free/reduced meals. If this is not available, they may submit a statement of family income and household size. The application will also state the student's instrument and the name and mailing address of their instructor. A committee of the SYS Board of Directors will review and approve the applications. All information provided by applicants will be treated with confidentiality.

**One or more** of the following documents is required and should be enclosed with applications:

- Copy of current National School Lunch Program eligibility documentation;
- Copy of the most recent signed Federal Tax form (1040, 1040A, or 1040EZ);
- Statement of need from a community resource worker, pastor, or other proof of income.
